
MARKET SURVEY

PROCESS DESCRIPTION

To complement the network development planning procedure, NET4GAS, s.r.o., as the exclusive gas transmission system operator (TSO) in the Czech Republic, is launching the capacity4gas process. NET4GAS subdivides the capacity4gas process into two phases. The first phase will start with a non binding market survey which will help to identify the proper development of the relevant gas infrastructure. It complements the efforts of similar surveys conducted by the Polish TSO and by the Gaspool market area TSOs (more capacity.eu) as the latter showed a need for extension of transmission capacity from Gaspool to the Czech Republic.

Technical studies may follow to prepare detailed specific development projects for new transmission capacity. Then, in the second phase, the new transmission capacity will be offered to the market through non discriminatory and transparent capacity allocation procedures, where network users will be asked for binding bookings to reserve transmission capacity. The allocation results will form a basis for subsequent investments in the relevant development of the network.

We believe that the capacity4gas process is suitable for determining specific network users' requests in the most efficient way. However, NET4GAS reserves the right to adjust the suggested process if appropriate. The capacity4gas process consists of the following main steps.



1. Market Survey

A market survey in which network users are asked to express their interest in new capacity between the Czech Republic and adjacent market areas on a non-binding basis.

2. Demand assessment

Once the Market Survey is complete, NET4GAS will analyze the capacity inquiries. Based on an assessment of the demand from the market survey and identified from the Union-wide Ten-year Network Development Plan and the TYNDP, a decision as to what possible projects should be developed will be adopted.



If the individual non-binding requests submitted or the requests as a whole are not sufficient to economically justify a project, the process will simply end with the publication of the demand assessment report.

3. Technical studies, planning of network development and allocation procedure

On the basis of the requirements identified during demand assessment, NET4GAS will produce technical studies to determine the capacity level for a specific existing or a new network point.

The technical studies will determine the necessary technical development measures, e.g. new pipelines, border transfer stations or compressor stations. The appropriate upgrading of the infrastructure will be based on the flow calculations for one or more capacity levels and will serve as an initial indication for the necessary investments.

In addition to the technical studies, NET4GAS will draft terms and conditions for offering the new capacity to the market. The allocation procedure, the contractual and financial arrangements, and the tariff structure will all be closely coordinated with the regulatory authority.

During this phase, proposals for one or more capacity levels and parameters required for the capacity allocation and the economic evaluation will be prepared.

4. Public announcement of the allocation procedure

At least two months prior to the start of the allocation procedure, NET4GAS will announce information regarding the new capacity allocation date, the allocation procedure, capacity levels at the relevant points, the tariffs and contractual provisions, as well as the expected minimum demand for passing the economic viability tests.

5. Capacity allocation

New transmission capacity will be allocated in a non-discriminatory and transparent procedure. The results will first be verified by the economic viability test that will prove the economic feasibility of the offered capacity levels. Once the test is completed, the capacity level which provides the greatest amount of new transmission capacity will be put in place.

6. Construction activities

Once the new transmission capacity has been allocated to network users, preparatory works for the necessary development projects will begin at NET4GAS. This includes, in particular, organizing engineering work, obtaining the necessary approvals, procuring materials, and arranging construction services. The construction phase will then begin.

TERMS AND CONDITIONS

The transmission system operator NET4GAS is launching a Market Survey to determine the need for new transmission capacity at the boundaries of the Czech Republic. It is designed to support the proper development of the relevant gas transmission infrastructure. Participation in the Market Survey is only possible under these Terms and Conditions of Participation in the Market Survey ("Terms and Conditions") and by submitting an inquiry form. By completing, signing, and returning the inquiry form (hereinafter referred to as the "Inquiry Form"), participants confirm that they have accepted the Terms and Conditions.

Participants shall provide non-binding details regarding their request for future need for transmission capacity at the boundaries of the Czech Republic (hereinafter referred to as the "Requested New Capacity").

All information about the capacity4gas process is available on the NET4GAS website.



This Market Survey is non-binding and is not connected in any way with an agreement or obligation in respect of any subsequent network development or the acquisition or reservation of the existing or new transmission capacity. It does not represent a request for connection to the transmission system. It is not necessary to take part in this Market Survey in order to take part in any subsequent allocation of existing and/or new transmission capacity.

The procedure for participating

NET4GAS reserves the right to modify the deadline for submitting the Inquiry Form in case unforeseen events occur while conducting the capacity4gas process, which will would force a change in the submission deadline. Inquiry Forms (in hard copy) which are received after the date specified above will not be considered in the demand assessment. By submitting the Inquiry Form, the network user agrees to pay a participation fee.

If participants submit a number of Inquiry Forms, only the last Inquiry Form received in a hard copy prior to the submission deadline will be evaluated. Incomplete Inquiry Forms will not be considered during the subsequent process.

Participants shall not be entitled to demand that the NET4GAS website is permanently available or that other technical requirements which are necessary for taking part in the Market Survey in a timely manner are met.

Participation fees

NET4GAS reserves the right to demand that participants pay a participation fee in accordance with the provisions below.

The participation fee shall be calculated according to the total quantity of new capacity requested by the participant. The participation fee may be levied if and when NET4GAS decides in the demand analysis produced on the basis of all the submitted inquiries to produce technical studies with a view to allowing all interested network users to book capacity during a subsequent transparent and non-discriminatory allocation. The participation fee shall be 10 CZK (plus VAT where applicable) per requested MWh/d of transmission capacity for which a technical study is to be produced.

NET4GAS will inform participants of this in writing once the demand analysis is complete and will prompt payment of the participation fee by a specified deadline. Inquiries from participants who have not paid the participation fee after the deadline expires shall not be taken into account in the technical study. Any participation fee that a participant has paid will be refunded in full by NET4GAS if the Requested New Capacity or capacity which exceeds the amount requested in connection with this Market Survey are booked on a binding basis by the participant or third parties, or if the subsequent process of the capacity4gas process does not lead to the sale of the new transmission capacities.



The participation fee paid shall be refunded proportionally by NET4GAS if the amount of binding bookings of Requested New Capacity is lower than the amount originally requested by the participant or third parties. In this case, the amount of the participation fee which is to be paid back to the participant shall be calculated using the following formula:

(Sum of the actually booked New Capacities / Sum of the initially Requested New Capacities) × Paid participation fee

In all cases, the participation fee paid by the participant is the maximum amount that can be refunded.
